

## **INTERNAL QUALITY ASSURANCE COMMITTEE (IQAC)**

The Internal Quality Assurance Committee of the College is constituted in accordance with Section 95 of the Maharashtra Public Universities Act, 2016.

- There shall be an Internal Quality Assurance Committee in the institute to plan, guide and monitor quality assurance and quality enhancement in all the academic activities of the institute.
- The Internal Quality Assurance Committee in the institute shall be constituted and function as per the guidelines of the University Grants Commission and State Government issued, from time to time.
- The Annual Quality Assurance Report shall be approved by the Management Council of the institute for the Follow up action for the necessary quality enhancement measures. The institute shall regularly submit the Annual Quality Assurance Report to the National Assessment and Accreditation Council or other accreditation bodies.
- There shall be an Internal Quality Assurance Committee in college that shall be constituted and function as per the guidelines of the University Grants Commission and State Government issued, from time to time.
- The institute shall monitor the functioning of Internal Quality Assurance Committee.

### **Objectives**

- 1) To ensure continuous improvement in the entire operations of the college.
- 2) To assure stakeholders connected with higher education – namely, students, parents, teachers, staff, employer, funding agencies and society in general – of the accountability of the college for its own quality and probity.

### **Role and Responsibilities**

- 1) Development and application of quality benchmarks/parameters for the various academic and administrative activities of the college.
- 2) Dissemination of information on the various quality parameters.
- 3) Organization of workshops, seminars on quality related themes.
- 4) Documentation of the various programs / activities leading to quality improvement.
- 5) Preparation of the Annual Quality Assurance Report (AQAR) to be submitted to NAAC based on the quality parameters.
